Terms and Conditions

GENERALITIES

All our sales are submitted to the following Terms and Conditions. Any purchase implies the full agreement of the buyer to these terms no matter what the buyer's terms are. The buyer's terms and conditions are not opposable to these conditions even if they are submitted beforehand. If one or several of the following conditions was cancelled or inapplicable, the other clauses would still be applied. The seller not mentioning or not using these terms and conditions to the buyer at a given time cannot be considered as a renunciation to these terms at other times. The seller promises to make the buyer benefit from the favourable conditions which could have been applied to any other buyer for an identical order and without real counterparties.

ORDER

All orders, even the ones made through a phone call or teletype, have to be confirmed by a written confirmation. Any order has to contain the quantity, the references, the agreed price, the delivery place and date if the delivery place is different to the address on the invoice. Any add up or modification of the order is applicable only if the seller accepted it by issuing a written confirmation. If, for a previous order, the buyer did not submit to these terms (such as late payment), the seller may refuse to deliver the goods unless the buyer provides the seller with satisfying guarantees or a payment beforehand. No discount can be given for a payment done before the delivery of the goods.

PRICE

The prices invoiced are the ones that were established on the day the order was made on the basis pricing conditions applied. They are applicable for a maximum time of 3 months unless mentioned otherwise on the invoice.

DELIVERY

The delivery is done following the stipulations mentioned on the confirmation of order, subject to the respect of the payment modalities. The delivery time are always given according to the production time at the time of the order and are given on an indicative basis. A late delivery for circumstances that are out of the seller's reach cannot be used as a reason to cancel the order. The seller cannot be held responsible for any incident resulting from late delivery. The seller cannot be held responsible in case of force majeure or exceptional circumstances such as strikes, lock-outs, epidemics, wars, requisitions, fires, floods, accidents, transport issues or any other circumstances that could prevent the seller or its suppliers from performing their work. The seller shall inform the buyer of the events mentioned above as soon as possible. Any late delivery due to force majeure will lead to, according to the seller's choice, the cancellation of the sale or a longer delivery time. In both cases, no party can request penalties. A delivery in time can only happen if the buyer has completed all of their obligations towards the seller. When the buyer picks up the goods at the warehouse of the seller, the latter shall let the buyer know about a date when the goods will be available in writing.

CLAIMS

Unless stated otherwise, shipment is always at the buyer's risk. It is expected that the buyer checks thoroughly the number and state of the goods delivered before accepting the delivery. In case of loss or damage, the buyer has to write down the damages or missing goods on the delivery slip and let the delivery company know of them within 72 hours (after the delivery) in writing. After this time, no claim will be acceptable. If the buyer expressly or tacitly renounces to this delivery, the goods will be deemed delivered in accordance with the order. The lack of conformity of a part of the delivery does not exempt the buyer from paying the goods for which there is no dispute. Any defect or defective workmanship recognised after an adversary examination obliges the seller only to replace, for free of charge, the defective goods, excluding any operating loss or additional loss. No return can be made without our written agreement.

PAYMENT

Unless otherwise agreed by the seller, invoices are payable to the seller's headquarters 30 days before the end of the month or on the 10th by LCR DIRECTE. All special conditions prior to 1st January 2009 are, as of that date, automatically reduced to the payment deadlines capped by the Law of Modernization of the Economy of 04/08/2008 or by the decrees of homologation of the derogatory agreements envisaged by this law. When entering into relations, the seller reserves the right to make the first deliveries against refund or to require payment in advance. Regardless of the method of payment agreed between the parties, the payment will only be considered to have been made after the effective payment of the price. In case of partial payment, this one will be imputed in priority on the penalties of delay, then on the current deadlines by order of seniority decreasing. In case of non-payment, even partial, the seller reserves the right to terminate or suspend orders and deliveries in progress.

PENALTY CLAUSE

In accordance with Article L441-6 of the French Commercial Code, penalties for late payment are applicable in cases where sums due are paid after the date of payment appearing on the invoice. These late penalties are calculated on the basis of 3 times the legal rate. If the deficiencies of the buyer necessitate a legal recovery, the buyer undertakes to pay, in addition to the principal, the costs, expenses and emoluments ordinarily and legally incumbent on him and an indemnity of 15% of the amount (usually with taxes included) of the claim as part of damages and conventional interests. In case of cancellation of the sale for default of payment, the sums paid by the buyer will be purely and simply acquired by the seller.

FORFEITURE OF THE TERM

In case of total or partial non-payment of an order at the due date, the sums due under this order or other orders already delivered or being delivered will be immediately due after formal notice.

TERMINATION CLAUSE

Any order is accepted in consideration of the legal, financial and economic situation of the buyer at the time of the order. It implies that if the financial situation of the buyer deteriorated between the date of the order and the date of delivery, the seller has the right either to require payment before delivery or to terminate the sale. In case of non-performance of only one of these conditions, the seller will send the debtor a formal notice by registered letter with acknowledgment of receipt. If the buyer fails to fulfill their obligation within one month from the sending of this formal notice, the sale will be automatically terminated if the seller agrees.

RETENTION OF TITLE CLAUSE

TRANSFER OF RISK

The property will remain the seller's until the effective payment of the full price following the terms of the Law of May 12, 1980. The non-payment, even partial, of any of the invoices may result in claiming property. The right of claim is exercised even in the case of receivership or liquidation of the buyer. In case of claim, the sale will be terminated automatically. By derogation to article 1583 of the Civil Code, the delivery of the goods carries risk transfer at the expense of the buyer, as well for the damage suffered by the goods or by any third party. The return of goods will be at the expense and risk of the buyer. In the event of implementation of the Retention of Ownership Clause, the advances paid to the seller will be retained by them as damages and interests.

APPLICABLE LAW AND JURISDICTION

This contract is subject to French law. For all the disputes relating to the execution or the interpretation of the present conditions, only the commercial court of DRAGUIGNAN will be competent. ■
